Solutions: POS / Inventory Management / Asset Management / Collaborative Planning / Traceability
Services: Global (GSMP, GEPIR, Global Registry, Training and Accreditation) & Local (e.g. Certification, Implementation, Training)

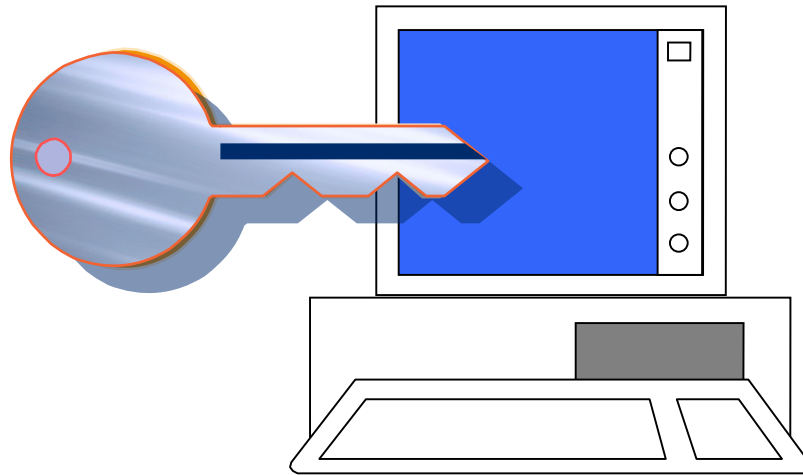
Global standards for RFID-based identification

More accurate, immediate and cost-effective visibility of information

GS1 Identification Keys (e.g. GTIN, GLN, SSCC, GRAI, GIAI, GSRN, EPC) & Attribute Data (e.g. Best Before Date)



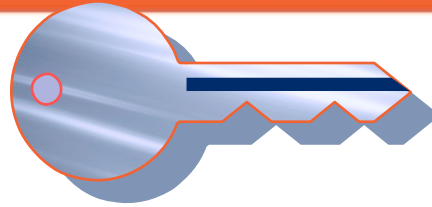
GS1 Identification Keys



GS1 Identification Keys provide access computer files



GS1 Identification Keys are:



- **Unique:** every variant of an item is allocated a separate unique number
- **Non-significant:** they identify an item but contain no information about it
- **International:** GS1 identification keys are unique across all countries and all sectors
- **Secure:** GS1 identification keys are fixed length, numeric and include a standard check digit



Global Trade Item Number

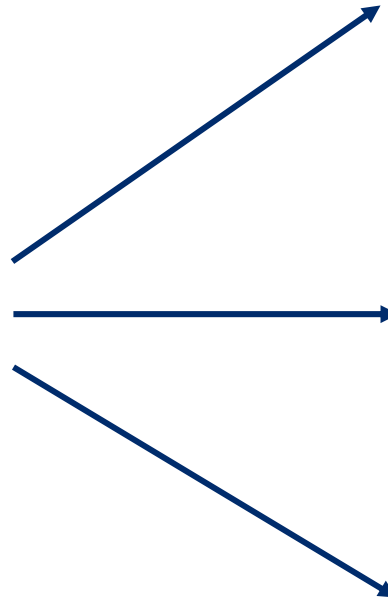
Any item (product or service) upon which there is a need to retrieve pre-defined information and that may be priced, or ordered, or invoiced at any point in any supply chain.

GTIN is umbrella term for all GS1 trade item identification numbers A Global Trade Item Number™ may use the GTIN-8, GTIN-12, GTIN-13, or GTIN-14 numbering structure.

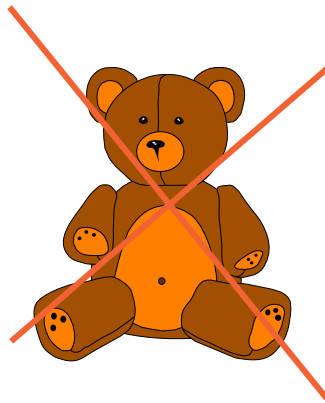
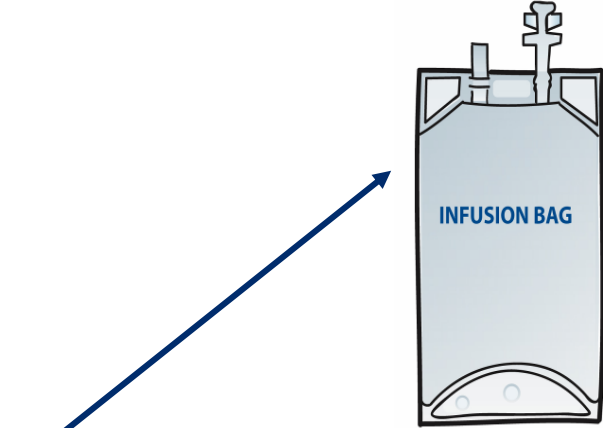


GTIN FUNDamental: 1 product = 1 GTIN





GTIN FUNDamental 1 GTIN = 1 product



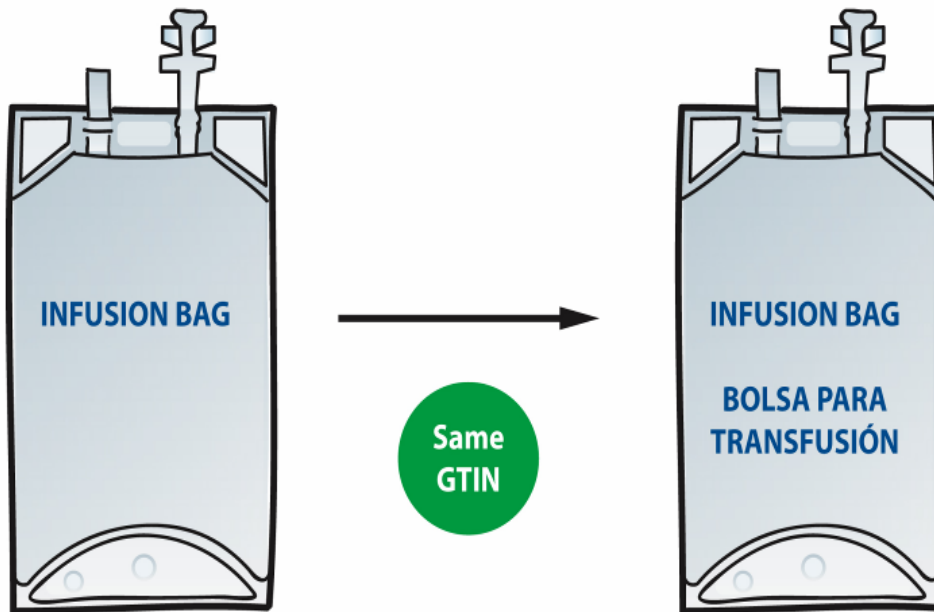

GTIN Allocation Rules for Healthcare

- Provides
 - A Simple and easy to use worldwide guideline
- GTIN also enables the addition of Attribute Data like:
 - Batch Number
 - Expiration Date
 - Serial Number

Using GS1 Application Identifiers



What is a GS1 Application Identifier (AI)?

- **AIs** are prefixes defining data field(s) that follow and indicate their format
- Example: **AI (21)** means "**serial number**" with a alphanumeric format, variable length up to twenty characters *an..20*

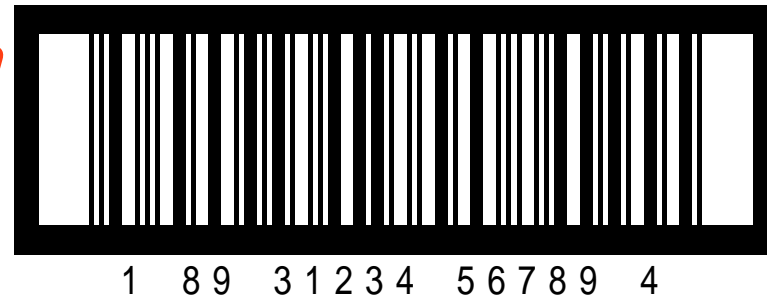

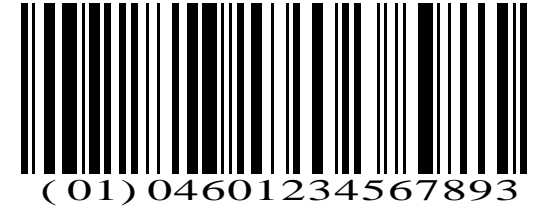

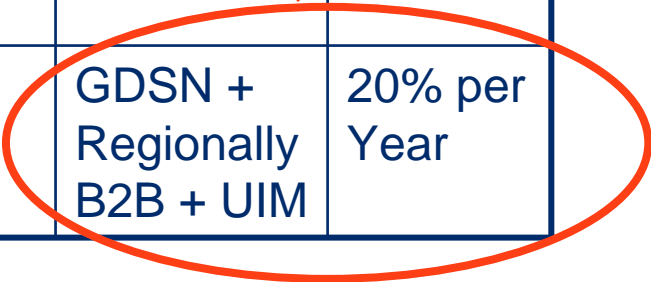
